#### **CALL TO ORDER**

The meeting was called to order by President Quinneka McDonald at 10:30 a.m.

**APPROVAL OF THE MINUTES** – September 17, 2025, Staff Senate Meeting

#### PRESIDENT'S REPORT

President Quinneka McDonald reviewed relevant meetings in which she attended.

On September 18, hosted a Welcome Reception with Guests Interim President Matt Lee and Interim Provost Troy Blanchard.

On September 22, attended a meeting regarding the LSU Early Childhood Education Laboratory Preschool, regarding personal concerns but highlighted a non-negotiable of a meeting to be held with faculty and staff to discuss previous concerns regarding the center, academic performance. As of last week, no response was provided to those updates.

On September 23, attended the University Council Meeting.

On September 26, attended a meeting with LSU Police Chief Marshall Walters regarding the Run, Hide, Fight training for staff.

On October 3, attended a meeting with a member of the University of Oklahoma Staff Senate to discuss communication and plans to potentially join an SEC Staff Senate Group.

On October 7, President-Elect Tammy Millican attended the Campus Safety and Security meeting on behalf of the Staff Senate.

President-Elect Tammy Millican reported that Scooters were discussed. LSU is going to work on reducing the speed and geographical fencing. Stickers are being put at entrances to let people know that scooters cannot be brought inside a building. A Scooter policy will be coming out soon.

They also talked about the establishment of a Campus Security Access office. That office is going to install access devices on campus that would allow us to shut the campus down by stopping people from going into the buildings or coming through the gates if there was some type of emergency. There was also discussion about communication across campus with regards to new construction, student housing, and parking.

On October 8, the Executive Committee met to prepare for the October General Meeting.

On October 8, Committee Chairs were invited to attend the Executive Committee meeting to share updates and ask questions. They have access to the Staff Senate Operational Cekander.
